Tuka Kumari BK (Dalit called untouchable poor women) -53, NP-6, Diguwa Syangja joined the Triangle Support Project. Her life was very hard. Her husband was a spendthrift and no income. She have big family (10 family members) with 4 children are going in school age. She has to send 4 childrens to school and she need to knock the door of the local money lender frequently for loan. She was having only 3 to 6 months of Food Sufficiency Status from his own production.



After joining to the triangle, she was very much like the model of support of ASK and Triangle. She obtained the NRs 4,000 through a village committee microloan without any interest and took other loan from personal money lender. she purchased 2 goats initially from the locality. After few months 2 goats give four and she started to rear. She already sold 2 goats of worth NRs 20,000 and paid back the personal money lender. Recently she has 5 goats when valuated by the local market price, goats worth more than NRs 40,000.

She is regularly contact us if she need any technical advice. Her husband has controlled started to help his wife in goat raising. Her 3 children are regularly going to school and now she is covering slowly slowly any type of financial crisis to handle the household economy. she told us with her smile when we are asking to say any if she has then she replied "I am going to increase my income because the Triangle who show the way for better sustainable income and would like to thank Triangle and the donors who supported".

<p>All planned activities were completed, which are described below:</p> <p>All the money Nrs 75000.00 invested for micro loan to women, poor and earthquake affected family's income generation and benefited 14 persons in different income base activities.</p>

<p>Public Social Audit: The people and the facilitators have learned that this is a necessary component to make the government and service provider accountable. We have trained the villagers, but the actual VDC Public Social Audit will take place later this year in the new context of restructure of federal state Nepal)</p> <p>Community Score Cards: It is one of the most important components to improve the government service to the peoples and make better and accountable of the service provider. 9. Micro finance update			
9.1 Money collected in the fund for microloan			
<p>The fund for providing microloans has increased over the last five years. Apart from the 75,000 NRS from 2016, a sum of 246,600 paid back from previous years and municipality has donated 29000 for poor to income generation was added to make 350600 NRS for distribution in 2016. The families, who</p>			

got the micro loan for goat raising, small poultry business promotion, pig raising and vegetables farming in 2015 have successfully repaid loans amounting to 246600 Nrs.

The 27 families who got the micro loan for goat raising, small poultry business promotion, pig raising and vegetables farming in 2015/016 have received a lot of benefits and extra money (Minimum Nrs 6000.00 to maximum Nrs 25000.00 extra in regular income) which was spent on dresses and books for their children, food and some clothes for the family. They feel that their livelihood is improving, and would therefore like to remember those who supported the village. The women, children and all the villagers' health and living situation has improved because of income generation activities and awareness. Now they are happy and give many many thanks to the supporters of their village with new concepts. People from the village are continuing their regular savings and credit in a sustainable way and almost all villagers are involved in the micro-credit group also. A lot of success has been achieved. For this report one of the most significant changes is the story that has been included in section 9.

9.2 Use of microloan and status

- 24 families got a microloan of Nrs 245600.00 (22 persons*Nrs 10000.00, 1 person*Nrs 13600.00 and 1 persons*Nrs 12000.00,) and have started raising of goats.
- 5 families got a microloan of Nrs 50000.00 (5 persons*Nrs 10000.00) and has started a small poultry business.
- 4 families got a microloan of Nrs 40000.00 (4 persons*Nrs 10000.00) and has started vegetables farming.
- 1 family got the microloan Nrs 15000(1 person*Nrs 15000.00) and started the pig raising.
