NP-55, Haleda, Kavre- By using mutual fund NRs 30000.00 of core program for road construction with partnership of municipality is now completed. After reconstruction of road the villagers are happy because now it is easy to go to the market in Nagarkot to sell the vegetables and milk.

The village was far from municipality headquarters. People had a lot of frustration because of no systematic development. So the citizens had no access and control of government resources. After they learnt the local democracy (SLP) from ASK/Triangle then it was possible to get the partial support from municipality for this project and other 2 project as well. Now people are happy and want to give thanks for the Danish individual donor.

6. How were beneficiaries selected?

After finishing the settlement level planning the village committee members again organized the meeting and made the criteria for distribution of money. Generally the villagers followed priorities for the distribution of money used by LGCDP (Local Governance and Community Development Program):

- Families with no or very little land
- Poor housing conditions
- Lack of food for the whole year
- Persons with labor-based livelihoods (for others)
- Unemployed families
- No guarantee for settlement, etc
- Most earthquake affected persons

7. Ongoing activities update, results of the activities

All planned activities were completed, The money DKK 5000 (NRs 75000) from Triangle annual member donation in Denmark is used for;

- Nrs 30000.00 spent for Seed distribution and it has been completed and 45 households got benefits.
- Nrs 25000.00 spent for road repairing and it has been completed. All villagers have access with the road to go to the market from the village.
- Nrs 20000.00 has been invested for vegetable farming to 4 farmers.

<p>Public Social Audit: The people and the facilitators have learned that this is a necessary component to make the government and service provider accountable. We have trained the villagers, but the actual VDC Public Social Audit will take place later this year in the new context of restructure of federal state Nepal)</p> <p>Community Score Cards: NA</p> <p>Right to Information : Facilitators have been trained and started to mobilization for public awareness.</p> <p>Other methods (SLP): This is a very good and participatory method to know the planning system and the selection of most needed projects.</p>
9. Micro finance update
9.1 Money collected in the fund for microloan
<p>The fund for providing microloans has increased over the last four years. Apart from the 20,000 NRS from 2017/018, a sum of 1,55000 paid back from previous years was added to make 175,000 NRS for distribution in 2017/018. The families, who got the micro loan for goat raising, small poultry business promotion, vegetables farming in 2016/017 have successfully repaid loans amounting to 155,000 Nrs.</p> <p>The 16 families who got the micro loan for goat raising, small poultry business promotion and vegetables farming in 2016/017 have received a lot of benefits and extra money (Minimum Nrs 7000.00 to maximum Nrs 15,000.00) which was spent on dresses and books for their children, food and some clothes for the family. They feel that their livelihoods is improving, and would therefore like to remember those who supported the village. The women, children and all the villagers' health and living situation has improved because of income generation activities and awareness. Now they are happy and give many many thanks to the supporters of their village with new concepts. People from the village are continuing their regular savings and credit in a sustainable way and almost all villagers are involved in the micro-credit group also. A lot of success has been achieved. For this report one of the most significant changes is the story that has been included in front page of this report.</p>
9.2 Use of microloan and status
<ul style="list-style-type: none"> 6 families got microloans amounting to Nrs 60000.00 (6 persons*Nrs 10.000) and have started raising goats. 13 families got microloans amounting to Nrs 115000.00 (9 persons*Nrs 10.000 and 5 persons*Nrs 5000.00) and started vegetable farming.
