Sabina Tamang-31, NP-58, Kafleni, Kavre joined the Triangle Support Project. Her life was very hard because of her husband has very little income so it was very difficult obtaining food because of low income. Vegetable production by using chemical is now very harmful. The soil is almost death and she was also always sick. The vegetable production was decreased as well so she has frequently need to knock on the door of the local moneylender for treatment and other basic need fulfillment.

Technology was provided by ASK Triangle organic farming and open her eyes. To do the organic vegetable she need some microloan and it was also possible because after joining the Triangle core project, she obtained the NRs 10,000 through a village committee microloan without any interest, which she used to organic vegetable farming. After few months she was able to produce many types of organic vegetables (like tomato, lettuce, coriander etc). While she sold them in market, she gains Nrs. 15000 extra in the first season. Now she has other vegetables for sale from the green house. Her income is increasing and she is not suffering from any type of financial crisis to handle the household economy and being healthier. Lastly she told "it was possible because of Triangle core program and specially individual donor who support Kafleni.

9. Micro finance update

9.1 Money collected in the fund for microloan

The fund for providing microloans has increased over the last five years. Apart from the 77000 NRS from 2017/2018, a sum of 135,000 paid back from previous years was added to make 219,000 NRS for distribution in 2017/018. The families, who got the micro loan for goat raising, small poultry business promotion and vegetables farming in 2016/017 have successfully, repaid loans amounting to 135,000 Nrs.

The 22 families who got the micro loan for goat raising, small poultry business promotion and vegetables farming in 2016/017 have received a lot of benefits and extra money (Minimum Nrs 7000.00 to maximum Nrs 15,000.00) which was spent on dresses and books for their children, food and some clothes for the family. They feel that their livelihood is improving, and would therefore like to remember those who supported the village. The women, children and all the villagers' health and living situation has improved because of income generation activities and awareness. Now they are happy and give many many thanks to the supporters of their village with new concepts. People from the village are continuing their regular savings and credit in a sustainable way and almost all villagers are involved in the micro-credit group also. A lot of success has been achieved. For this report one of the most significant changes is the story that has been included in front page of this report.

9.2 Use of microloan and status

- 15 families got microloans amounting to Nrs 150,000 (15persons*Nrs 10000.00) and have started raising goats.
- 7 families got microloans amounting to Nrs 67000.00 (6 person*Nrs 10000.00 and 1 person*Nrs 9000.00) and started vegetable farming.
